ENGLISH MEDIUM SCHOOL PROVISION

NOTICE IS HEREBY GIVEN in accordance with Section 28(1) (b) of the School Standards and Framework Act 1998, and the Education (School Organisation Proposals) (Wales) Regulations 1999 (S.I. 1999/1671), that the Council of the City and County of Cardiff (herein after "the Authority"), having consulted such persons as appeared to them to be appropriate, proposes to:

Make a prescribed alteration to Mount Stuart Primary School, Adelaide Street, Butetown, Cardiff, CF10 5BS (hereinafter "the School") by increasing its capacity to 420 places.

The number of pupils on roll at the School at September 2012 was 306. The school currently accommodates up to 296 pupils aged 4-11. Following the implementation of the proposal it is intended that the primary school should be able to accommodate up to 420 pupils aged 4-11.

At the time of publication the standard number in the relevant age group at age 4 or 5 is 42.

It is proposed that the standard number for the relevant age group at age 4 or 5 in the first school year in which the proposal is implemented will be 60.

The number of pupils admitted to the school in the relevant age group at age 4 or 5 at September 2012 was 51.

It is intended that the proposal will be implemented from September 2015.

The School will continue to be a community school and to admit pupils of both sexes.

The Authority has responsibility for admitting pupils to the School and sets the admission criteria.

Any arrangements for the transport of pupils will be made in accordance with the Authority's existing policies on school transport. Within a period of 1 month after the date of publication of this proposal, that is to say by 01 August 2013 any person may object to the proposal. Objections should be sent to the Chief Officer, Education Service, Cardiff County Council, County Hall, Atlantic Wharf, Cardiff CF10 4UW.

Please note that any objection sent by post or e-mail must contain the full name and postal address of the objector.

The Authority will send copies of any such objections made (and not withdrawn in writing) within the objection period, together with its observations thereon, to the Welsh Government within a period of 2 weeks after the end of the objection period.

The proposal will (unless withdrawn) require the approval of the Welsh Ministers if,

- within 2 months after a copy of the proposal is sent to the Welsh Ministers they give notice that they require such approval; or
- any objection has been made within the objection period and has not been withdrawn in writing during that period.

Where a proposal does not require such approval, the Authority will decide whether to implement the proposal. Such determination shall be made within 4 months after a copy of the said proposal was sent to the Welsh Ministers and the determination shall then be notified to the Welsh Ministers.

EXPLANATORY NOTE

(This does not form part of the Notice but is intended to explain its general meaning.) It is proposed to increase the capacity of Mount Stuart Primary School from 315 to 420 places. This will be achieved by extending and adapting the school premises.

The admissions criteria of the nursery and the primary school will be made available as part of the Council's "Admissions to Schools" booklet. The school will continue to serve its existing catchment area.

RHODDR HYSBYSIAD TRWY HYN yn unol ag adran 28(1)(b) Ddeddf Safonau a Fframwaith Ysgolion 1998, a Rheoliadau Addysg (Cynigion Trefnadaeth Ysgolion) (Cymru) 1999 (S.I. 1999/1671), fod Cyngor Dinas a Sir Caerdydd (sef "yr Awrdurdod" o hyn ymlaen) wedi myngynghori â'r unigolion priodol, yr cynnig:

Gwneud addasiad rhagnodedig i Ysgol Gynradd Mount Stuart, Stryd Adelaide, Butetown, Caerdydd, CF10 5BS (sef "yr Ysgol") drwy gynyddu nifer y llefyd yno i 420 o lefydd.

Nifer y disgylion ar gofrestre yr Ysgol ym mis Medi 2013 oedd 306. Ar hyn o bryd mae gan yr ysgol le i hyd at 296 o ddisgyblion 4-11 oed. Ar ôl rhoi'r cynnig ar waith bwriadir i'r ysgol gynradd allu gynni lle i 420 o ddisgyblion 4-11 oed.

Ar yr adeg cyhoeddi nifer safonol y grŵp oedran perthnasol yn 4-5 oed fydd 42.

Cynigir i nifer safonol y grŵp oedran perthnasol yn 4-5 yn y flwyddyn ysgol gyntaf fod yn 60.

Nifer y disgylion a dderbynnyd i'r ysgol yn y grŵp oedran perthnasol yn 4-5 oed ym mis Medi 2012 oedd 51.

Bwriadir gweithredu'r cynigion hwn o fis Medi 2015.

Bydd yr Ysgol yn parhau'n ysgol gymunedol a bydd yn parhau i dderbyn disgylion sy'n fechwyn neu'n ferched.

Yr Awrdurdod sy'n gyfrifol am dderbyn disgylion i'r Ysgol a phennu'r meinu prawf derbyn.

Bydd unrhyw drefnadau ar gyfer cludo disgylion i'r ysgol yn cael eu gwneud yn unol â pholisiau presennol yr Awrdurdod ar gludo plant i'r ysgol.
