- Pupil medical details (allergies, doctors' details, emergency contact procedure)

This is collected for the purpose of safeguarding pupils, billing, events and activities planning, statistical reporting, tutor and school scheduling)

Microsoft hold an ISO 27001 accreditation as well as being part of the British Government G-Cloud scheme. The data ais encrypted at all times.

CARDIFF AND VALE MUSIC EDUCATION will keep your personal data if agreed for the duration of active lessons or activities being delivered. Once any active tuition or activities cease, the account will be archived. After a dormant period of 3 years has passed all data relating, you're your account will be anonymized.
