Public Spaces Protection Order  
1-2 Deere Place, Ely 2024

Notice Is Hereby Given that the County Council of the City and County of Cardiff (“the Council”) has on 24 May 2024 made the above order under Section 59 of the Anti-social Behaviour, Crime and Policing Act 2014 (“the Act”) and all other enabling powers

The effect of the order, which will come into force on 31 May 2024 will be to restrict, by the erection of barriers in the locations as described in the Order, all public access through:

The public path between 1-2 Deere Place, Ely, Cardiff (“the Restricted Area)

at all times, with the exception of those persons exempt under the Order for the purpose of reducing crime and anti-social behaviour in “the Restricted Area”.

A person may apply to the High Court for the purpose of questioning the validity of the Public Spaces Protection Order on the grounds that that Council had no power to make the Order or that any procedural requirement was not complied with in relation to it. An application must be made within six weeks from the 24 May 2024 to the High Court for this purpose.
