THE COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF (PROHIBITIONS AND RESTRICTIONS OF STOPPING, WAITING, LOADING AND STREET PARKING PLACES) (CONSOLIDATION) ORDER 2023 (AMENDMENT NO.1) ORDER 2024

The County Council of the City and County of Cardiff in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act"), Part 6 of the Traffic Management Act 2004, The Civil Enforcement of Parking Contraventions (City and County of Cardiff) Designation Order 2010, The Civil Enforcement of Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013 and of all other enabling powers and after consultation with the Chief Officer, South Wales Police, in accordance with Part III of Schedule 9 of the 1984 Act, proposes making an Order the general effect of which will be to **establish a Disabled Persons' Parking Place (for use by any Disabled Persons' Badge Holder) in the length of road referred to in the Schedule below (as shown on Map Tile Reference AB27 annexed to the draft Order).**

Exemptions will be permitted for the following reasons:

- a. Boarding or alighting from a vehicle
- b. Emergency services
- c. Essential services

A copy of the draft order and plan showing the location and extent of the restrictions are available and you can obtain a copy by sending an email request to <u>roadtrafficorderobjections@cardiff.gov.uk</u> or by making a written request to the address below. Full details of the order are also available at <u>www.cardiff.gov.uk/trafficorders</u>.

Any objections and other representations relating to the order must be submitted in writing on or before 10th January 2024 or by email to <u>roadtrafficorderobjections@cardiff.gov.uk</u> and must contain the grounds on which you object. Correspondence may be disclosed as required by the Freedom of Information Act 2000.

This Notice may be removed after the objection period ends. The Council welcomes correspondence in English and Welsh and we will ensure that we communicate with you in the language of your choice, whether that's English, Welsh or bilingual as long as you let us know which you prefer. Corresponding in Welsh will not lead to any delay. This document is available in Welsh/Mae'r ddogfen hon ar gael yn Gymraeg.




On its east side from a point 39 metres south east of its junction with Monthermer Road for a distance of 6.6 metres south


