

Llandaff North: Gabalfa Primary School And Ysgol Glan Ceubal

Consultation Report

Project No: CO17000

A consultation was held on the above scheme proposals between 31/08/2017 and 15/09/2017.

The purpose of the consultation was to obtain information from the local community in order to improve the scheme and if possible address any local concerns.

From the 43 properties consulted and 4 site notices displayed on site, 1 individual telephone response was received.

The concerns and comments are summarised in *italics* below, along with the Council's response.

Recommendation

In view of the below it is proposed to proceed with the implementation of the scheme as outlined in the consultation plan.

Issue – Displacement of Parking and Driveway Access

The resident was concerned about their driveway being blocked by parents parking near the school, and that the zig-zag road markings would reduce the amount of available parking.

Response

The roads are public highway and therefore all members of the public have equal rights in law to make use of the roads, subject to any restrictions present. Residents have no greater rights to use the road in which they live than any other person.

The zig-zag road markings associated with the zebra crossing extend for no more than approximately 16 metres either side of the crossing location, and as such, any displaced parking will not be over a significant distance.

Cardiff Council is aware of the demand for parking and we take all measures to maximise the available space within these types of scheme. However, the safety of pedestrians and facilitating safe convenient pedestrian movement, particularly to and from schools, is considered very important. In accordance with the Council's policies and strategy, this takes precedent over parking provision. However, we will take these views into consideration and will see what can be done during the detailed design process to improve parking availability.

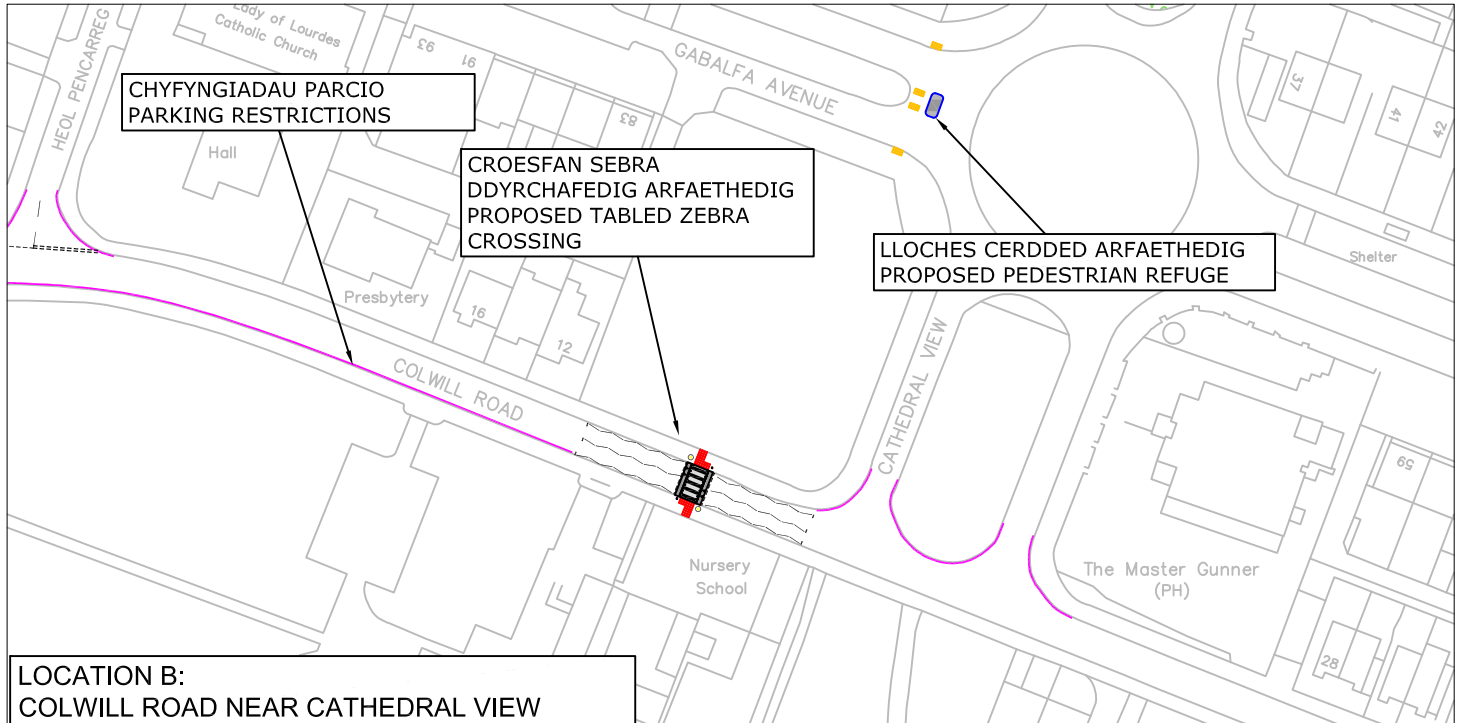
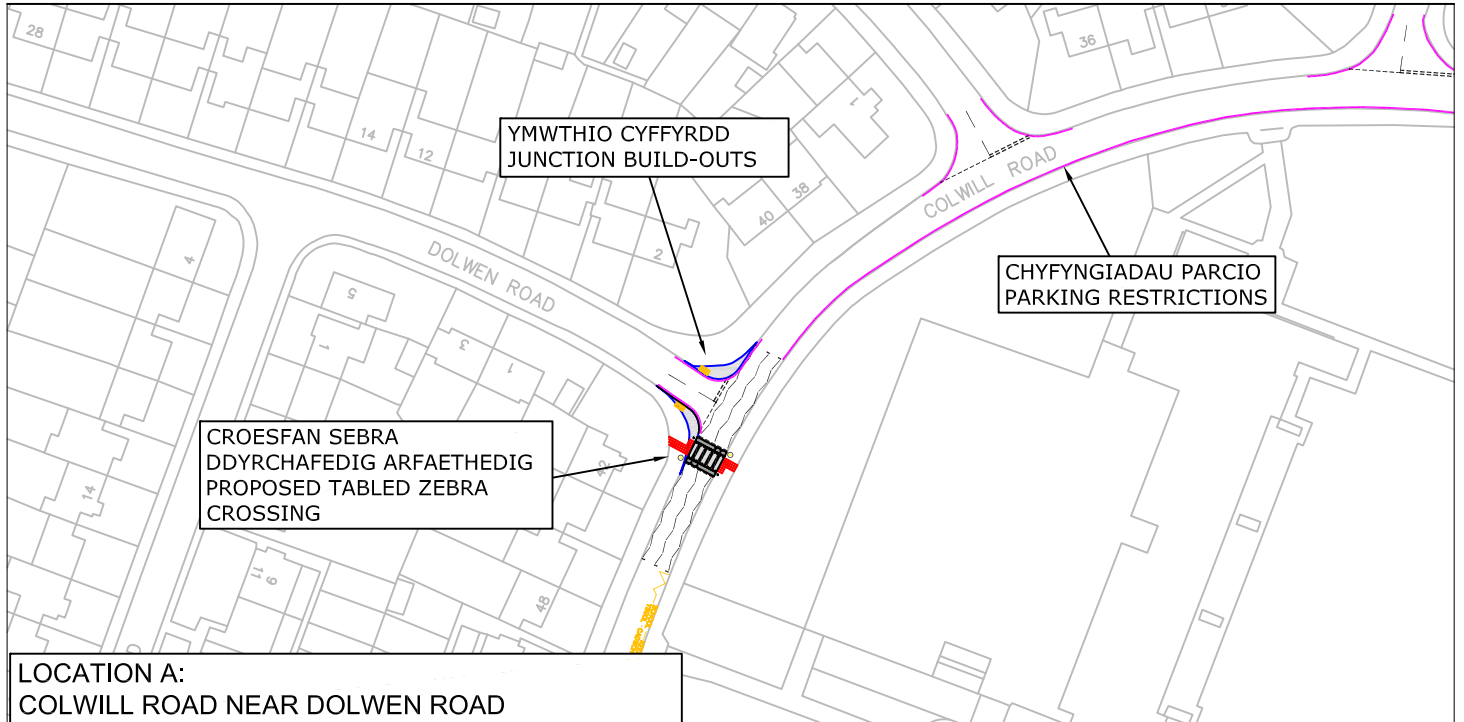
The obstruction of driveways and failing to comply with parking restrictions is a matter that may be dealt with by the Council's Civil Parking Enforcement Officers
